OLD BUSINESS:

Maintenance Fees:

The 2024-2025 Fiscal Year Maintenance Fee Invoices were mailed May 20, 2024.

The Treasurer developed a payment plan with 2 due dates—June 15 and November 19, should the need arise.

The Secretary will send a courtesy email remainder to lot owners of the Maintenance Fee due date of June 15, 2024, and the delinquency penalty applicable for payments not received by July 15th.

Bylaw & Covenants Revision;

Report: 41 Amendment Consent Form Ballots were received of the 112 total mailed to lot owners subject to the covenants. 36.6% responses received, with 28 YES votes and 13 NO votes, resulting in ratios of 68.2% in favor to 31.8% opposed, The Amendment was notarized with Jim McGillis, BWRMA President and Ilona Bell, BWRMA Secretary as required signors for

recording. The Condominium Law group will complete the process, provide results and possible steps going forward..

NEW BUSINESS:

Standing Committees Reports:

The Finance Committee: BWRMA Treasurer, Bridget Richardson, is the Board member on this Committee. No report.

The Road Maintenance Committee: Committee Member Don Layton is the Board member on this committee to represent neighborhood interests with the specific goal of maintaining neighborhood roads.. Don Layton and Fred Bell met on May 14th with Lakeside Industries to bid repairs to the entire loop of Bywater Road, in preparation for future resurfacing. Areas in need of attention were marked with spray paint. A quote was received from Lakeside Industries. Dolittle Construction did not respond to a requested quote. Lakeside Industries provided a bid of \$59,650.43, to repair 13,500 square feet of Bywater North and Bywater South roads. Dolittle Construction was contacted for a chip seal bid, with no response to date.

The Budget for gravel roads is \$18,000. The bid was \$25000 to grade, shape and compact 4 gravel roads. The Road Committee will determine necessary required work to be completed within the allocated budget.

Don Layton moved and **Bridget Richardson** seconded a motion to approve the 5/21/24 Lakeside Proposal Agreement in the amount of \$59,650.43 to repair 13,500 square feet of Bywater North and Bywater South roads. **THE MOTION CARRIED UNANIMOUSLY.**

As usual, lot owners will be notified of the road work expected to be completed this summer.

<u>The Covenants Committee</u>: Jim McGillis is the Board member of this committee. Jim McGillis mailed the recorded Amendment Consent Form Vote and required documents to the Condominium Law Group. Upon completion of the process, the vote results to be relayed to our community.

<u>Legal Letters</u>: Legal opinion letters are kept on file.
